OFFICIAL CONTEST RULES

CONTEST PERIOD

The Contest is offered during one (1) contest period as indicated below. One (1) prize in total will be awarded during the contest.

• Contest Period: the contest will run from 11:00am ET -11:59pm ET on May 29th, 2021.

The Contest is sponsored by World Vision Canada ("WVC").

ELIGIBILITY

This Contest is open to any person who (i) follows the Challenge Instructions below for an entry into the Contest within the contest period and enters their email address in the designated contest sign up page;

Challenge Instructions

- 1. Pick a container to use as your "Jerry Can."
 - Between 0 lb 40 lb in weight.
 - Examples: milk jug, backpack filled with books or a bucket the options are endless.
- 2. Fill your "Jerry Can"
 - Consider using something reusable like sand or marbles vs. water.
- 3. Walk a portion of your 6K with your "Jerry Can" or challenge your Team to carry it between you for the full 6 kilometres.
- 4. Take a picture of you or your team with your "Jerry Can."
- 5. Upload your picture using the form <u>online here</u> for a chance to win.
